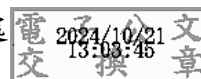

2025 National Science and Technology Council Graduate Research Fellowship Pilot Program-- NSTC Selection

(Revised based on NSTC Official Document NO. 1130073142 Oct. 21, 2024)

1. Purpose of the Program :

The program is established by the National Science and Technology Council (hereinafter referred to as NSTC), aiming to build a solid foundation of research talents and reserve talents for core strategic industries. The program awards outstanding Ph.D. students who have demonstrated their potential for significant research contributions and supports them to pursue full-time doctoral degree. (This pilot program is called this fellowship hereinafter.)

2. Eligibility for Application :

First-year doctoral students (who obtain new student status in February 2025 or September 2025) expected to be enrolling in public or private universities in Taiwan (hereinafter referred to as the enrolled schools) in 2025.

3. Maximum Number of Award :

Applicants must select key research areas and submit their own application materials through the website (log in Academic Research Service Portal: <https://gov.tw/4r2>). NSTC conducts academic reviews, selects up to 400 awards in accordance with national development and talent cultivation needs.

4. Amount and Duration :

Each fellowship recipient will be granted a monthly stipend of NT\$40,000 for a period of up to 3 years, starting from the first year of the Ph.D. program. Stipend for those who graduate less than three years shall last until the month of graduation. The entire stipend is offered by NSTC.

5. Eligibility to Claim the Fellowship:

- (1) Applicants will receive a confirmation letter from the NSTC once their applications are accepted through academic reviews and they need to matriculate and finalize their enrollment in the first year of the PhD program in the specific time required by their respective colleges/universities.

The recipients will be awarded “NSTC Graduate Research Fellowship (NSTC-GRF)” title and certificate and their respective colleges/universities will submit receipts of fund withdrawal in accordance with NSTC’s instruction.

- (2) The following individuals are not eligible to receive this fellowship:
 - a. Those who are engaged in full-time paid employment in public or private sectors or who are part-time students.
 - b. Students from Hong Kong, Macau, and Mainland China.
 - c. Those who have applied for leave of absence and retained their admission eligibility or have not completed registration after admission.
 - d. Those who are concurrently in receipt of scholarship or subsidy offered by the ROC government.

6. Application documents Required and the Procedure :

Applicants should log in and upload the required documents on the NSTC website (<https://arspb.nstc.gov.tw/NSCWeb/slogin.jsp>) within the specified period. Incomplete submission will be given a limited time for correction after the online submission. Failure to correct within the given time or incomplete corrections will result in rejection:

- (1) Information form
- (2) Application Forms(Less than 10 pages)
 - a. Personal Resume
 - (i). Your motive for studying in the PhD program and reasons for doing researches in specific fields.

- (ii). An Introduction of your research history, including your publications (dissertation, journal articles and seminar papers, books, technical reports) and research results (Number and amount of patent approvals, authorizations, IPR and technology transfers)
- b. Research Proposal
 - (i). Your research topic in doing the PhD program
 - (ii). Research goals and background
 - (iii). Research methods and steps
 - (iv). Anticipated research findings
 - (v). References
- (3) Academic credentials
- (4) Transcripts from undergraduate or higher
- (5) Other favorable review materials (Certificates of Language Proficiency Test or Recommendation letters).

7. Review Process

- (1) Evaluation criteria include the applicant's academic performance, future potential, research experience, and research topic, as reviewed by experts in relevant fields. The review Scoring items are as follows :
 - a. Reasons for studying the major area and an introduction of past learning history (40%).
 - b. The innovativeness of your research topic for the doctoral degree, the completeness and feasibility of the research proposal, and its significance for Taiwan 's future development (40%).
 - c. Correlation between research capability, research expertise, and key research area (20%).
- (2) After the evaluation process being completed within four months from the day of the submission deadline, the selection list will be finalized and announced. The process may be extended if necessary.

8. Fellowship Disbursement :

The fellowship is disbursed in two installments each academic year. The enrolled schools should submit a list of awardees along with receipts of fund withdrawal in accordance with NSTC's instruction and the disbursement will be made starting in the month when they formally enrolled into the PhD program.

9. Performance Assessment :

NSTC reserves the right to retrieve funds from the enrolled schools if the recipient is found to be ineligible.

Recipients' eligibility for fellowship renewal in each academic year is subject to review according to the regulations set by the applicant institutions. Recipients must continue to cooperate with NSTC to track their academic progress at school and professional accomplishment after graduation within three years.

10.Implementation Schedule :

This pilot program will be reviewed annually in a rolling manner to adjust its content as needed to align with policy requirements and fully realize its anticipated benefits.

一、獎勵目的

國家科學及技術委員會（下稱國科會）為充實科研人才基盤及儲備核心戰略產業人才，獎勵拔尖、具有研究潛力之博士生，支持其專心從事研究工作，特訂定博士生研究獎學金試辦方案（下稱本方案）。

二、申請資格

預計於114年註冊入學就讀國內公私立大學校院（下稱就讀學校）之博士班一年級新生（於114年2月或114年9月取得新生學籍）。

三、獎勵名額

由申請人自行研提資料並勾選重點研究領域後，完成線上送件，經國科會就學術專業進行審查，依國家發展及培育人才需求，擇優獎勵名額最多不超過400名，依審查結果而定。

四、獎勵金額及期限

每名博士生每月獎學金四萬元，自博士班一年級起獎勵三年；於三年內畢業者，獎勵至畢業當月止。獎勵金額全數由國科會負擔。

五、請領資格

（一）申請人所送文件，經專業學術審查獲得通過，國科會將函發核定函即代表申請人獲得獎勵資格，惟須於114年

取得博士班入學資格，並依所就讀之學校規定期間註冊入學就讀。就讀後國科會將授予受獎人「NSTC Graduate Research Fellowship (NSTC-GRF)」頭銜及頒發證書。後續由就讀學校向本會請領獎學金。

(二) 如有下列情形之一者，不得請領本獎學金。

1. 於公私立機構從事專職全時之有給職工作或以在職生身分報考者。
2. 以香港、澳門及大陸地區學生身分入學者。
3. 錄取後辦理休學、保留入學資格或未完成註冊者。
4. 已支領同屬政府部門獎學金性質經費者。

六、申請文件及送件程序

B.研究目的及背景

C.研究方法及步驟

D.預期完成項目及成果

E.參考文獻

3. 學歷證明文件

4. 大學以上歷年成績單

5. 其他有利於審查資料(如語言能力證明或推薦信)。

七、 審查作業

(一) 以申請人學術表現、發展潛力、參與計畫經驗、研究主題等為評審基準，送請相關領域專家學者審查資料。審查評分項目如下：

1.個人簡歷：修讀專業領域之理由及過去學習歷程簡介。(占40%)

2. 研究計畫：未來修讀博士班預計研究主題之創新性；研究計畫內容完整性、可行性，及對國家未來發展之重要性。(占40%)

3. 研究能力、研究專長與重點研究領域之關聯性。(占20%)

(二)自截止收件之次日起四個月內完成，並核定公布；必要時，得予延長。

八、 獎學金請領

獎學金每學年分二期撥付，由就讀學校統一造具獎勵名冊並檢附領款收據(溯自受獎人114年註冊入學成為博士班一年級生起應領之獎學金，併入首期請領)依國科會核定通知函規定辦理請領。

九、 執行考核

受獎人如經發現有資格不符者，國科會得向就讀學校追回該部分之款項。

受獎人每學年之續領資格依就讀學校訂定獎勵規定進行審

查，並須持續配合國科會追蹤在校期間之學業研究表現，以及畢業後三年內之流向。

十、 實施期程

本試辦方案採逐年滾動檢討方式，俾能配合政策需求，適時調整方案內容，以充分發揮本方案預期效益。
